RESOLUTION 20-12-173 ACCOUNTS PAYABLE

WHEREAS the municipality has received confirmation from the Quebec government of a grant of \$35,614 in the context of the COVID-19 pandemic to mitigate the impact of the pandemic on the municipality's finances;

WHEREAS the Town wishes to use this amount to improve the quality of life of these citizens by relying on a good quality of infrastructure associated with active displacement in the municipality;

FOR THESE REASONS,

It is proposed by Councillor Ms. Rita D. Turriff and unanimously resolved that the Town of Métissur-Mer Council allocates the amount of \$ 35,614 for sidewalk repairs to the 2021 budget.

8. URBANISM

8.1 Recommendation of the Local Heritage Council for the Lighthouse Site.

RESOLUTION #20-12-178 RECOMMENDATION OF THE LOCAL HERITAGE COUNCIL FOR THE LIGHTHOUSE SITE

WHEREAS the Association des residents de la Pointe du Phare de Métis-sur-Mer Inc. and the Town signed a 15-year long term lease on November 22 2018 to manage the Pointe-Mitis lighthouse Site.

WHEREAS a local heritage Council was established in May 2018;

WHEREAS the Town has received a recommendation from the local Heritage Council with the resolution 20-11-02;

WHEREAS this recommendation mentions that the town should give annually, for a period of 3 years, namely for the years 2021, 2022, and 2023, an amount of \$10,000, to the association in order to help them financially, to protect and upkeep the Pointe-Métis Lighthouse and its dependencies.

FOR THESE REASONS,

It is proposed by Councillor Mr. Raynald banville and resolved unanimously that the Council of the Town of Métis-sur-Mer accepts the recommendations of the local Heritage Council and agrees to pay an amount of \$10 000 annually for the years 2021, 2022 and 2023.

8.2 Application for a renovation permit in PIIA area at 484 rue Beach.

RESOLUTION #20-12-179 APPLICATION FOR A RENOVATION PERMIT IN PIIA AREA AT 484 RUE BEACH

The application for a building permit is for the replacement of windows on the main building in the PIIA zone.

CONSIDERING THAT the replacement of the components does not alter the overall composition of the building, remove an element intrinsic to the architectural style of the building, or break with the uniformity of the same component.

CONSIDERING THAT on the facades visible from the street, the type, position, shape, size, symmetry, rhythm and the doors and windows material are inspired by those of existing buildings in Métis-sur-Mer;

It is proposed by Councillor Ms. Martine Bouchard and resolved unanimously that the Council of the Town of Metis-sur-Mer accepts the recommendations of the CCU and allows the application as presented in all documents submitted for the approval of an application for building permit in area PIIA.

Turriff and unanimously resolved that the Council accepts this donation and allocates this amount as specified in the confirmation letter by the foundation's director, Mr. Stuart Iverson, to purchase the compressor trailer for \$114,650 plus applicable taxes.
