# 6.1- SETTING UP AN ANIMAL MANAGEMENT SERVICE RESOLUTION NO. 21-09-124

**Considering that** the Town of Métis-sur-Mer has taken cognizance of the Program of the Volet 4 - Support to the intermunicipal cooperation of the Fonds régions et ruralité

**Considering that** the MRC de La Mitis would like to present a request for the realization of a feasibility study regarding the implementation of an animal management service in order to respond to the application of the Act respecting the control of dangerous dogs

**For these reasons,** it is proposed by Mr. Simon Brochu and unanimously resolved that the present resolution be adopted and that it rules and decrees as follows

- The council of the city of Métis-sur-Mer is committed to participating in the feasibility study and providing the information necessary for its completion;
- Council authorizes the submission of the project to the Fonds régions et ruralité,
  volet 4 Soutien à la coopération intermunicipale;
- > The council appoints the MRC de La Mitis as the organization responsible for the project.

#### 7- URBAN PLANNING AND ENVIRONMENT

## 7.1- PRESENTATION OF A PIIA AT 1 CHEMIN BOULE ROCK RESOLUTION NO. 21-09-125

**Considering** the request for a certificate of authorization for the demolition, within the PIIA zone, of the main building bearing civic number 1, Boule Rock road

**Considering that** the total demolition of the building does not create a permanent hole and that the applicants wish to rebuild a new building subject to the SPAIP by-law

**Considering** the general state of deterioration of the building and the recommendation of the Planning Advisory Committee, in order to grant the request as presented

**For these reasons,** it is proposed by Mr. Raynald Banville and unanimously resolved to grant the certificate of authorization for the demolition of the main building, bearing civic number 1, Boule Rock Road, which is located in the SPAIP zone.

# 7.2 SUBMISSION OF A PIIA AT 289 BEACH STREET RESOLUTION NO. 21-09-126

**Considering** the request for a construction permit for the extension of the main building located at 283 Beach Street, which is in the SPAIP zone

**Considering that** the site retains its natural characteristics and that the enlarged building does not obstruct views of elements of heritage or landscape interest from the public road;

Whereas the roof form and pitch remain unchanged or are similar in appearance to the building types in the historic areas;

**Considering that** the height and width of the enlarged building are approximately the same as the already enlarged portion of the main building located to the east of it

**Whereas,** on the building facades that are visible from a public or private way, the type of material, arrangement, texture and colors used for the exterior wall cladding of the annexed portion are similar in appearance or visually complement the original portion;

**Considering that** on the facades of the building that are visible from a public or private road, the type, shape, size and symmetry of the window of the annexed part is not similar to those of the original part In particular, with the portion of the main building that has already been expanded to the east of the main building;

**Considering** the recommendation of the Planning Advisory Committee, with regards to granting the request as presented in its entirety, with the request that the new window be identical to the existing window in the eastern part of the main building already expanded

**For these reasons,** it was moved by Mrs. Martine Bouchard and unanimously resolved to approve the request for a building permit for the extension of the main building bearing civic number 283 Beach Street in the SPAIP zone, as presented in its entirety, provided that the new window is identical to the existing window in the eastern part of the main building already extended.

# 7.3 APPOINTMENT OF A COUNCIL MEMBER TO THE PLANNING ADVISORY COMMITTEE RESOLUTION NO. 21-09-127

It is proposed by Mr. Simon Brochu and unanimously resolved to appoint Mrs. Martine Bouchard as a member of the Planning Advisory Committee, replacing the resigning Councillor Mr. Luc Hamelin.

## 7.4- REQUEST FROM MRS. DANIELLE BOUILLON OF 506 BEACH STREET RESOLUTION NO. 21-09-128

**Considering** the request from Mrs. Danielle Bouillon, of 506 Beach road, in order to be able to connect the effluent of her septic installation which ends with a UV treatment, to the storm sewer of the Town of Métis-sur-Mer

**For this reason,** it is proposed by Mrs. Martine Bouchard and unanimously resolved to authorize Mrs. Danielle Bouillon to connect the effluent of her septic installation, serving her residence located at 506 Beach Street, to the City's storm sewer which is located in front of her property. However, the City is not responsible for any malfunction or blockage of said storm sewer, including blockage due to freezing of the pipe.
