5.1 Request to the MRC - PM-150 Fund - electric charging station.

CONSIDERING THAT the Town of Métis-sur-Mer wants to be part of the Electric Circuit by offering a place at the Halte-sur-Mer to install an electric charging station.

CONSIDERING THAT this investment is part of the actions to be taken to combat climate change.

CONSIDERING THAT the Town of Métis-sur-Mer will sign a partnership agreement with Hydro-Québec for the management of the charging station and therefore adheres to the rules of operation of the Electric Circuit.

FOR THESE REASONS,

A resolution has been adopted by the Town to request the MRC de la Mitis to provide \$7,225 in financial assistance under the PM 150 Fund.

5.2 Partnership agreement with HQ for the deployment of charging stations for electric vehicles.

A resolution has been adopted by the Town to authorize the Director General to sign the partnership agreement for the deployment of electric vehicle charging stations with Hydro-Québec to acquire a charging station and install it on a Town parking space to provide a charging service for electric vehicles.
